FL602 Formed a new CoC Lead Agency, the Gulf Coast Partnership. Due to this change, we were required to create a new Secure Server account and new eLOCCS user accounts in order to drawdown for the current grant term.

The HMIS Renewal Project has a start date of March 1, 2018, a Contract date of May 18, 2018, and we did not have the ability to access our eLOCCS account until September 11, 2018.

Previous drawdowns had been at least quarterly and consistent. Now that we have access to our newly created eLOCCS account, we will be able to drawdown, at least quarterly, on a consistent basis.

Scope:

FL-602 has maintained a consistent HMIS Lead since 2003 and an active and robust HMIS. We continue to offer HMIS to additional agencies and have increased training frequency and curriculum to all users. The use of HMIS has continued to grow and expand in both users and scope of use as well as adding additional modules such as FundManager & CommunityPoint. In reaching out to non-profits, government agencies, and faith-based providers; the HMIS Project has made inclusivity of all community partners our major priority.

FL-602's HMIS, Wellsky Community Services (formerly ServicePoint)/Mediware Systems, is recognized by HUD, compliant with all HUD Data Standards, and includes HEARTH Act Revisions and is a statutory requirement for recipients and subrecipients of CoC Program and Emergency Solutions Grants (ESG) funds.

Community Need, Design and Implementation:

The HMIS Lead successfully transitioned the Charlotte 211 Call Center, and with this system wide change, we are able to capture more accurate community data referral information and sharing of information between direct service providers has proven to be an invaluable tool for agencies and clientele. In continuing partnership with our local County government, we are bringing all Human Services clients into our HMIS implementation for unparalleled coverage of persons within our CoC. We have also integrated 211 as an access point into our One Charlotte Coordinated Entry Process in order to provide 24-hour 7 day a week coverage for our entire CoC.

Anticipated Outcomes:

We strive to ensure that our the process is easy for people to access, identifies and assesses their needs, makes prioritization decisions based upon needs and vulnerability, and refers them to appropriate housing options. Our CoC Triages everyone immediately so they do not languish on long waiting lists, and only support providers who use a housing first approach to screen clients INTO the right services quickly, not OUT. We are a HOUSING FIRST community and our primary goal is to ensure that assistance is given no matter where or how people present.

Outcome 1. All agencies will be actively participating in the Coordinated Entry Process.

Outcome 2. Increase Data Quality for all participating agencies, and

Outcome 3. Increase % of agencies that complete annual updates.
